


CheddarUp



CHANGE TO RULES AND REGULATIONS

In August, the board voted to change Rule 15 to now read: All construction must be approved by the Architectural Committee. Prior to going to the City of Bonney Lake, Members should get preliminary approval from the Architectural Committee that their project meets Lake Jane standards, as Lake Jane's standards may be more restrictive than the city's. Then when the city has reviewed and approved the project, the Architectural Committee will review and provide final approval, assuming the project continues to meet Lake Jane's standards.

LAKE REPORT

The lake started in good shape this spring after last fall and winter rains helped fill it back to normal level after the large drop during last summer.

Earlier this spring someone removed the debris cage from the lake outlet and it had to be replaced. The debris cage is there to keep debris from plugging the pipe crossing the road. The cage is constantly monitored and debris is removed as needed. If you see debris blocking the cage, contact the lake committee and we will make sure it is removed.

The existing buoy line at the east end of the lake has been replaced with new lines along with added signage to deter people from fishing. It is an unsafe location to fish from as the roadway shoulder is narrow and we have had a history of non-members fishing from this location.

The annual fishing derby took place on Saturday, June 1st. There was a good turnout and some large fish were caught with the largest weighing over 4 pounds.

We lost our contract with the lake treatment company and had to find a new one, NW Aquatics has been retained to continue our lake treatments with the first treatment taking place June 4th. The treatment has been successful as the amount of vegetation has been greatly reduced from what was present last year. We will be monitoring the lake to see if spot treatments will be necessary this fall. NW Aquatics will come out for an inspection in late September/early October to check and see if a spot treatment is necessary - we will publish the date of the inspection as soon as it is solidified.

We have continued monitoring the lake water this year for clarity, depth, and dissolved oxygen levels. The lake water has been clear to date. The water depth has generally been greater this year compared to last year due to the relatively mild summer. Throughout the summer we were adding water to the lake from a well but it does not have the capacity to keep up with the evaporation. The lake level will start to level off and rise as we move into the rainy season.

Many residents have been using the lake to boat, fish, and swim which is great to see. Remember if you have guests who are fishing there is a \$5.00 fee for each guest. Payment can be made at the box located in the lower park.

PARK REPORT

It has been a beautiful summer, and many people are enjoying the parks! Park reservations have been going well, it is nice to see people using the facilities. Moles are always an issue, and Jay is trying to keep ahead of them. Wasps were an issue this year - we did our best to eliminate the ones that were brought to our attention. This summer we are seeing higher temperatures and have been watering more to keep the lawn under control. Jay has been walking the park more than usual. Trespassers have a big issue this summer and Jay has been responding as much as he can to deter repeat offenders.

Park Hours:

UPPER PARK: Summer hours for March through September are from 7:00 am to 10:00 pm and Winter hours for October through February are from 7:00 am to 6:00 pm.

LOWER PARK: Summer hours for March through September are from 7:00 am to dusk and Winter hours for October through February are from 7:00 am to 6:00 pm.

After-hours use of either park will be permitted to members in good standing by a decision of the Board of Trustees. Forty-eight hours' notice must be given to the Board for such special use.



SECURE MAIL DROP BOX FOR PAYMENTS COMING SOON!

This fall, a secure mail drop box will be installed near the pool so that members who prefer to drop-off their payments off will have a place to do so securely. Watch for the installation to happen soon and we will send out notification when it is ready to accept payments.
